INSTRUCTIONS
FOR CATEGORY 'EE' MEMBERSHIP

GENERAL

1. All Pakistani & NICOP Citizens are eligible for membership.
2. Original CNIC/Passport **MUST** be in possession while appearing before DHA Designated Officer.
3. EE Membership is mandatory for CBK project.
4. This Membership is specific to CBK project only and renewable after every **05** years, on deposit of renewal fee.
5. Cat "EE" can buy property in DHA Karachi but cannot buy property in DHA City Karachi.
6. Applicant is required to appear personally before the DHA Designated Officer for membership formalities (Biometrics & Photographs) on the next day of depositing fee.
7. **Same day** process of Membership will be conducted on depositing **URGENT** fee.
8. **Membership card** will be issued/dispatched on the given address after 21 working days.
9. Membership having Cat 'A' membership need not to get "EE" Cat Membership.

COMPLETION OF FORM

1. In case of more than one marriage, details of all wives are required (On extra sheet).
2. All attached documents must be readable.
3. No overwriting/cutting/erasing is acceptable.
4. Incomplete forms will not be accepted.
5. No column to be left blank.
6. All columns must be filled in **CAPITAL LETTERS**.
7. Non-Muslims are exempted from Mosque fund.

DOCUMENTS TO BE ATTACHED

1. Pay Order/ Bank Draft for Registration fee as per Membership Category (including Form charges) payable to Pakistan Defence Officers Housing Authority, Karachi (Photocopy of the same to be attached)
2. Two latest passport size photographs duly attested (One on front & one on back).
3. Two copies of CNIC/NICOP/POC/Passport (as applicable) duly attested. Attested photocopy of NADRA Form "B" for children (Pakistan Nationals) under 18 years of age.
4. Passport /CNIC of children over/under 18 years for person having Pakistan Origin Card or Overseas Pakistan Card (NICOP) duly attested.
5. Affidavit on Rs. **100/-** Non Judicial stamp paper duly attested by Oath Commissioner (Specimen enclosed).
6. 1 x passport size photograph of each living family member & photocopy of CNIC duly attested (Over 18 years of age).
7. Attested copy of death certificate of deceased family member (Parents, Spouse/Children) only to be attached.
